Relevant Experience is defined as under:

Quantity Estimator: Estimating, Costing (Rate Analysis) and preparation of Bill of Quantities.

Utility & Traffic Diversion Engineer: Candidates should have sufficient experience in traffic diversion and utility diversions in urban areas.

Contract Expert: Experience in dealing with contracts for large scale Project. Experience in FIDIC Conditions of Contract and Projects involving funding institutions like World Bank, Asian Development Bank, African Development Bank and Japan International Cooperation Agency will be preferred. Qualification in IPR/Contract Law will be given additional weightage.

Resident Engineer: Experience in planning, designing, construction, integration and commissioning of civil engineering works of large scale projects. Construction of viaduct, bridges / flyovers having large diameter piles, segmental construction, pre-stressing, pre-cast elements, station buildings including services, construction planning & resources planning.

Candidates having experience in Metro /Railway Projects will be preferred.

Candidates can apply for more than one post. However, separate online registration and application has to be sent for each post applied to.

Experience shall be calculated as on 21.09.2015 (Last date for online application).

SC/ST/OBC candidates should have atleast 50% marks in Minimum Qualification to be eligible.

Note for Educational Qualification:

The candidate should possess full time Degree/Diploma approved by UGC/AICTE; from a University incorporated by an Act of Central or State legislature in India or other Educational Institutions established by an Act of Parliament or declared to be Deemed as University under Section 3 of the University Grants Commission Act, 1956. Sections A & B examination of the Institution of Engineers (India) which is treated as equivalent to Degree/Diploma by Govt. of India, shall also be accepted.

Relaxations & Concessions

Reservation, relaxation & concessions to SC/ST/OBC/PWD/Ex-Servicemen would be provided as per extant Govt. orders.

Selection Process

Out of all the eligible candidates, a shortlist to the extent of 5 times the number of vacancies shall be prepared (category-wise). While shortlisting, first preference shall be given to candidates having experience in Metro/Railway Projects, followed by other candidates.

All shortlisted candidates shall be called for the Personal Interview.

The final merit list shall be prepared as per the following weightage distribution:

Qualification	-	20%
Experience	-	20%
Interview	-	60%

Merit list of only those candidates shall be prepared who secure a minimum of 60% marks in aggregate as well as in the Interview (50% for SC/ST/OBC).

Appointment of selected candidates will be subject to their being found medically fit in the Medical Examination to be conducted as per RITES Rules and Standards of Medical Fitness for the relevant post

Candidates have the option to appear for interview either in Hindi or English.

Remuneration

The selected candidates on contract would be paid Basic pay and DA fixed/variable allowances as applicable in the scale, HRA/Lease, Contribution to PF, Gratuity as per Gratuity Act. Other benefits would be as under:

 - e. Certificate in support of claim of belonging to Scheduled Caste, Scheduled Tribe and Other Backward Classes, Ex-Serviceman or Physically Handicapped, where applicable as GOI prescribed formats.
 - f. Certificate in support of claim for age concession, where applicable.
