IOB gets fresh capital of ₹4,360 cr

CHENNAI-BASED PUBLIC SECTOR lender Indian Overseas Bank (IOB) on Friday said it has been sanctioned a fresh capital infusion of ₹4,360 crore by the Centre in the current financial year. IOB had received a capital infusion of around ₹3,857 crore in September this year.

"The bank has received vide letter dated December 25, 2019, a sanction from government of India for release of ₹4,360 crore towards contribution of the central government in the preferential allotment of equity shares (special securities/bonds) of the bank during 2019-20, as government's investment," IOB said in a filing to stock exchanges.

Reeling under the impact of the ageing sticky assets and consequent higher provisioning, IOB had reported over five-

fold increase in its net loss at ₹2,253.64 crore for the second quarter of FY 2020, as compared to a net loss of ₹487.26 crore in the corresponding quarter last fiscal.

The total income had declined by 6% to ₹5,024 crore as compared to ₹5,348.35 crore, even as provisions had gone up to ₹2,996.04 crore during the quarter from ₹2,016.60 crore in the same quarter last year.

On the asset quality front, the gross non performing asset (NPA) of the bank came down to ₹28,673.95 crore during the quarter, which as a percentage of

gross advances was at 20% as compared to ₹37,109.96 crore (24.73%) during the same period last year. Net NPA also came down to ₹12,507.97 crore (9.84%) as compared to ₹18,876.05 crore (14.34%) during the same period last year.

Karnam Sekar, MD & CEO of IOB, earlier had exuded confidence that the bank was on track of its plan to come out of prompt corrective action (PCA) framework by March 2020. With the September quarter results, the bank was closer to the goal, when compared to the June quarter performance, he had said.

Uco Bank to get ₹2,142 cr

PUBLIC SECTOR LENDER Uco Bank on Friday said it will get a fresh capital infusion of ₹2,142 crore from the government.

The central government on December 26 conveyed its sanction for release of ₹2,142 crore towards contribution of the government in the preferential allotment of equity shares of Uco Bank, the lender said in a stock exchange filing.

The bank's capital adequacy ratio stood at 11.44% and CET-I ratio at 8.93% as on September 30, 2019. Net loss for the second quarter this fiscal reduced to ₹891.98 crore from ₹1136.44 crore for the same period last fiscal.

शनिवार का था। निजी विश्वविद्यालय दादात सभारह में सम्मान होने का अपना कार्यक्रम रद्द कर दिया।

भाजपा प्रवक्ता एस जी सुरया के अनुसार सिंह ने 'तमिलों और तमिलनाडु की भावना का सम्मान' करते हुए अपनी यात्रा 'रद्द' कर दी है। उन्होंने ट्वीट किया, "हमें सुनने को मिल रहा है कि तमिलों और तमिलनाडु की भावना का सम्मान करते हुए रक्षा मंत्री राजनाथ सिंह ने वैरामुथु को डॉक्टर दे देने के सिलसिले में अपनी यात्रा रद्द कर दी है।" उन्होंने तमिल लोगों और भाजपा कार्यकर्ताओं की भावना का सम्मान करने के लिए सिंह और भाजपा को धन्यवाद दिया। हवाई अड्डे के सूत्रों ने भी बताया कि रक्षा मंत्री ने अपनी चेन्नई यात्रा रद्द कर दी है। निजी विश्वविद्यालय की टिप्पणी नहीं मिल पाई है।

गुरुवार को जब विश्वविद्यालय का यह फैसला सामने आया था कि वह शनिवार को दीक्षांत समारोह में वैरामुथु को मानद डॉक्टर प्रदान करेगा और उस कार्यक्रम में सिंह भी शामिल होंगे तो विवाद खड़ा हो गया था। दो हिंदू संगठनों ने इस कदम का विरोध किया था कि और कहा कि वे विश्वविद्यालय के बाहर काला झंडा लेकर प्रदर्शन करेंगे। हिंदू मुन्नानी ने आरोप लगाया कि वैरामुथु ने महिला वैष्णव संत अंडाल के खिलाफ विवादास्पद टिप्पणी की थी जिसके बाद राष्ट्रीय फिल्म पुरस्कार विजेता गीतकार के खिलाफ प्रदर्शन हुआ था। उनके खिलाफ पुलिस में भी शिकायत दर्ज है। हिंदू मुन्नानी ने कहा कि वह सिंह के खिलाफ भी प्रदर्शन करेगा।

इसरो के पूर्व वैज्ञानिक को मिलेगा 1.3 करोड़ रुपए मुआवजा

तिरुवनंतपुरम, 27 दिसंबर (भाषा)।

केरल सरकार ने 1994 में जासूसी के एक मामले में गलत तरीके से फंसाए गए इसरो के पूर्व वैज्ञानिक एन. नारायणन को सैद्धांतिक रूप से 1.3 करोड़ रुपए मुआवजे के तौर पर देने का निर्णय किया है। नारायणन (77) ने यहां की एक उप अदालत ने एक मामला दायर किया था जिसमें उन्होंने अपनी अवैध गिरफ्तारी और परेशान किए जाने के लिए मुआवजा बढ़ाने की अपील की थी।

सुप्रीम कोर्ट के आदेश के बाद राज्य सरकार ने पूर्व वैज्ञानिक को 50 लाख रुपए दिए थे तथा राष्ट्रीय मानवाधिकार आयोग ने भी नारायणन को 10 लाख रुपए देने का सुझाव दिया था। यह मुआवजा इन राशियों के अतिरिक्त है। सरकारी वक्तव्य में कहा गया है कि कैबिनेट की बैठक में बृहस्पतिवार को यह निर्णय लिया गया। बैठक में यह भी निर्णय लिया गया कि कानून विशेषज्ञों से विचार विमर्श के बाद समझौता करार अदालत में पेश किया जाएगा और अदालत के निर्देश के अनुरूप आगे की कार्यवाही की जाएगी।

सरकार ने नारायणन द्वारा उठाए गए मुद्दों की जांच और मामले को निपटाने की जिम्मेदारी पूर्व मुख्य सचिव के. जयकुमार को सौंपी थी।
