Correction Slip No. 4

(1) SECTION 1 -NOTICE INVITING TENDER AND INSTRUCTIONS TO TENDERERS

Clause 11.0 AUTHORITY TO SIGN

A new para f) may be added as given below:

f) If the tenderer is individual /sole proprietor/proprietary firm as per a) & b) above and if such tenderer wants to act through an agent; he/she should submit along with the tender, a copy of power of attorney duly stamped and authenticated by a Notary Public or by Magistrate in favour of the specific person in line with Clause 28(3) and as per Annexure III, specifically authorizing him to sign the tender, submit the tender and further to deal with the Tender/ Contract up to the stage of signing the agreement and thereafter till the complete discharge of all the contractual obligations, failing which tender shall be summarily rejected. If the tenderer is an individual, he/she may modify Annexure III accordingly.

(2) SECTION 1 -NOTICE INVITING TENDER AND INSTRUCTIONS TO TENDERERS

Clause 1.1 Tender Notice

A new Clause 1.1 (a) may be added below clause 1.1 as given below:

1.1 (a) Category of this Tender: Works

(3) ANNEXURE III (FORMAT FOR POWER OF ATTORNEY TO AUTHORISED SIGNATORY) to SECTION 1-NOTICE INVITING TENDER AND INSTRUCTIONS TO TENDERERS

Ist Para of ANNEXURE III “We, M/s.....thereafter till the expiry of the contract agreement” may be deleted and replaced with following:

We, M/s..... (name of the firm/company with address of the registered office) hereby constitute, appoint and authorize Mr./Ms..... (Name and residential address) who is presently employed with us and holding the position of and whose signature is given below as our Attorney to do in our name and our behalf all or any of the acts, deeds or things necessary or incidental to our bid for the work (name of work), including signing and submission of application/proposal, participating in the meetings, responding to queries, submission of information/documents and generally to represent us in all the dealings with RITES or any other Government Agency or any person, in connection with the works until culmination of the process of bidding, till the Contract Agreement is entered into with RITES and thereafter till the complete discharge of all the contractual obligations.




(4) ANNEXURE IV (FORMAT FOR POWER OF ATTORNEY TO LEAD MEMBER OF JOINT VENTURE) to SECTION 1-NOTICE INVITING TENDER AND INSTRUCTIONS TO TENDERERS

The last but one Para of ANNEXURE IV starting with “We, M/s..... M/s.....and M/s.....hereby designate” and ending with “thereafter till the expiry of the contract agreement” may be deleted and replaced with following:

We, M/s.....,M/s.....and M/s.....hereby designate M/sbeing one of the members of the JV, as the Lead Member of the JV, to do on behalf of the JV, all or any of the acts, deeds or things necessary or incidental to the JV’s bid for the work, including submission of application proposal, participating in meetings, responding to queries, submission of information/documents and generally to represent the JV in all its dealings with RITES or any other Government Agency or any person, in connection with the work until culmination of the process of bidding till the contract agreement is entered into with RITES and thereafter till the complete discharge of all the contractual obligations.
