were served Memorandum cum Show Cause notice vide letter No.2023/GS(Elect.)/240/1 (Zetwerk & PTPS) dated 05.07.2023, served through CORE/Prayagraj. In the said Show Cause notice, Ministry of Railways had proposed to ban business dealings with **the above mentioned firms on all Indian Railways & Production Units etc. under the Ministry of Railways for a period upto two (02) years.**

Joint Venture (JV) of

(a) M/s Zetwerk Manufacturing Businesses Private Limited, Bengaluru and

(b) M/s Joint Stock Company Purpetruboprovodstroy (PTPS), Russia

have participated in the RFP no EPC/PSI/160kmph/ECR01 with closing date 08.09.2022 for the work of "Design, Supply, Erection, Testing & Commissioning of Traction Sub Stations with associated Switching Posts for 2 x 25 kV AT feeding system in Pradhankhanta - Manpur GC Section of Dhanbad Division and Manpur – Deendayal Upadhyay GC Section of Deendayal Upadhyay Division of East Central Railway for raising of speed to 160 Kmph".

Verification of the certificates submitted by the bidder against the mandatory technical compliance laid down in the RFP mentioned above was sought through Indian Embassy in Russia, Moscow. The Joint Venture was found indulging in fraudulent practice in the RFP for the EPC tender.


The representation of M/s Zetwerk Manufacturing Businesses Private Limited, Bengaluru was received through CORE in which it filed a WRIT Petition no. 23552/2023. M/s Joint Stock Company Purpetruboprovodstroy (PTPS), Russia did not make any representation. Consequently, CORE recommended for Banning of Business with the firms mentioned above except M/s Zetwerk Manufacturing Businesses Private Limited, Bengaluru for two (02) years.

It has therefore been decided by Ministry of Railways (Railway Board) to give effect to the order to ban future business dealings with the firms
