Sub: Banning of business dealing with the firm M/s. Aleena Comercial Private Limited, Unit No-233, 2nd Floor, Upohar Town Centre, 2052 Chakgaría, Panchasayar, Near Peerless Hospital, Kolkata, West Bengal for a period of two years – Regarding.

With reference to the E-Tender notice vide ref (i), a tender was floated for executing the work of "Supply & Laying epoxy Heavy duty non-inflammable sloped epoxy flooring in RMPU trough floor in the roof area of the RMPU Unit (FRP & Metal Trough) and sealing of joint with fire retardant water leaking proof sealant and tape in 50 Nos. of LHB AC coaches" at Central Workshops, Southern Railway, Goldenrock, Tiruchchirappalli-620004.

On scrutiny of the tender credentials, suspicion arose in the laboratory test reports submitted by the L1 tenderer - M/s. Aleena Comercial Private Limited, Unit No - 233, 2nd Floor, Upohar Town Centre, 2052 Chakgaría, Panchasayar, Near Peerless Hospital, Kolkata, West Bengal. In order to confirm the genuineness of the laboratory test reports, a confidential letter was sent to the concerned laboratory under whose name the reports were furnished by the L1 tenderer. But the concerned laboratory have communicated that they have not issued any such test reports to M/s. Aleena Comercial Private Limited in the year 2023 and in that they have not received any samples from them in the year 2022 and 2023. Thus It is found out that the L1 tenderer M/s. Aleena Comercial Private Limited, Kolkata, West Bengal had submitted fake test certificates and hence L1 tenderer was disqualified and rejected.

As per latest General conditions of contract, the L1 tenderer had submitted signed declaration certificate in the format as per Annexure-V. In that, clause 8 of the Annexure-V is as follows:

"I/we understand that If the contents of the certificate submitted by us are found to be forged/false or incorrect at any time during process for evaluation of tenders, it shall lead to forfeiture of the Bid Security besides banning of business for a period of upto two years. Further, I/we and all my/our constituents understand that my/our offer shall be summarily rejected."

In view of the above, it is hereby stated that M/s. Aleena Comercial Private Limited, Unit No-233, 2nd Floor, Upohar Town Centre, 2052 Chakgaría, Panchasayar, Near Peerless Hospital, Kolkata, West Bengal has been banned from any business for a period of upto two years with immediate effect.
