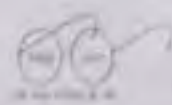

**SUB: REGARDING BLACKLISTING OF GRAMIN VIKAS TRUST AND BEING BARRED FROM PARTICIPATION IN ANY TENDER OF EAST DELHI MUNICIPAL CORPORATION FOR A PERIOD OF TWO YEARS.**

Sir/Madam,

1. This is to state that M/s Gramin Vikas Trust (a society promoted by KRIBHCO Limited) having its address at KRIBHCO Bhawan, 5th Floor, 'A' Wing, Plot No. A-10, Sector-1, NOIDA-201301 had participated in a tender issued by East Delhi Municipal Corporation (EDMC) namely DEVELOPMENT OF HEALTHCARE CENTER OF EXCELLENCE ON VACANT LAND OF EDMC LOCATED WITHIN THE CAMPUS OF BHAMASHAH MATERNITY HOSPITAL IN KHICHRIPUR, DELHI - NO. AC/RPCELL/EDMC/2019/D-1125 DATED 07/03/2019 (ANEXURE I).
2. That despite EDMC having issued Letter of Intent (LoI) to them vide letter number AO/RPC/EDMC/2018/D-704 Dated 10/10/2018 (ANEXURE II) and repeated reminders, GVT did not provide acceptance for implementing the project as per terms and conditions in the Letter of Intent/tender documents nor did they execute the agreement/furnish applicable performance guarantee for over 3 months from the date of issue of LoI.
3. Hence, on account of non-performance by GVT, it has been blacklisted and debarred from participating in any tender for a period of 2 years as per approval granted by Worthy Commissioner, EDMC on 08.03.2019. A copy of the letter issued by EDMC to GVT has been enclosed at ANNEXURE III.
